

Sallee Horse Vans Inc. Ipad giveaway online contest Rules and Regulations 2012

1. Contest Period: The “ipad giveaway” contest begins Monday, May 21, 2012, and ends Thursday June 30th, 2012. Contest is sponsored by Sallee horse Vans Inc. in Lexington, Kentucky
2. Eligibility: Kentucky Resident who must be at least 18 years of age (by May 7, 2012). Employees, agents, or representatives of the Sponsor and its affiliates, or the Sponsor and its affiliates are not eligible to win, nor are the parents, siblings, and children of any such employee, agent, or representative or any person with whom such employee, agent, or representative is domiciled.
3. Prizes: One (1) Entrant will win one (1) ipad with wi fi in black. Non-transferable, has no cash value. Winner to be selected by the Sponsor. Prize must be picked up by the winner with a valid photo ID during business hours M-F 9a-5p at Sallee Horse Van offices in Lexington off Buck lane.

Additional entries will be considered void. One random winner will be selected by Sallee horse Vans using the entire mailing sign up list. Selection of ONE Contest Winner will be performed by Commonwealth Eye Surgery based SOLELY on medical evaluation. If winner cannot claim their prize before 30 days after initial contact, sallee Horse Vans may choose to select an alternate winner or keep the prize.
